ORDER OF EXCLUSION

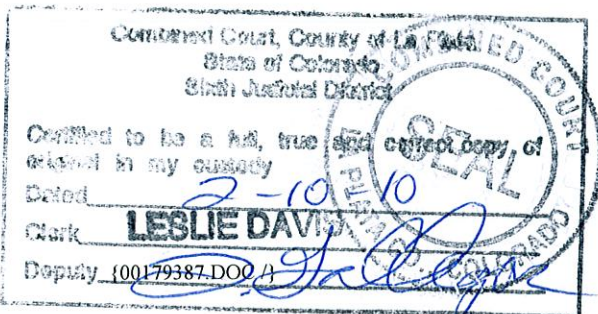
